

**Ent Webber International University and
its branch campus St. Andrews University (“the institution”)
45 Day Report as required by US Department of Education (“the Department”)
Date of Report Submission: April 10th, 2022**

Section 18004(e) of the Coronavirus Aid, Relief, and Economic Security Act (“CARES Act” or the “Act”), Pub. L. No. 116-136, 134 Stat. 281 (March 27, 2020), directs institutions receiving funds under Section 18004 of the Act to submit (in a time and manner required by the Secretary) a report to the Secretary describing the use of funds distributed from the Higher Education Emergency Relief Fund (“HEERF”). Pursuant to guidance received by the Office of Postsecondary Education on May 6, 2020, as of April 10th, 2022 we report as follows:

1. We acknowledge that we have signed and returned to the Department the Certification and Agreement and provide assurance that we have used, or intend to use, no less than 50 percent of the funds received under Section 18004(a)(1) of the CARES Act to provide Emergency Financial Aid Grants to students.
2. We have received, on May 18th, 2020, \$735,270.00, on January 15th, 2021, \$735,270, and on May 15th, 2021, \$2,020,169 from the Department pursuant to the institution’s Certification and Agreement [for] Emergency Financial Aid Grants to Students.
3. The total amount of Emergency Financial Aid Grants distributed to students under Section 18004(a)(1) of the CARES Act as of the date of submission is \$3,490,708.98.
4. The estimated total number of students at the institution eligible to participate in programs under Section 484 in Title IV of the Higher Education Act of 1965 and thus eligible to receive Emergency Financial Aid Grants to students under Section 18004(a)(1) of the CARES Act: 917.
5. The total number of students who have received an Emergency Financial Aid Grant to Students under Section 18004(a)(1) of the CARES Act: 689.
6. The method(s) used by the institution to determine which students receive Emergency Financial Aid Grants and how much they would receive under Section 18004(a)(1) of the CARES Act.

Distribution Round 1

Distribution Class 1.1 Graduates: The institution had 160 Title IV eligible domestic undergraduate students who completed or were scheduled to complete their degree in May of 2020 (Distribution Class 1.1). We allocated \$300 for each student in this class, for a total of \$48,000. To receive this payment students must have completed a simple on-line form providing their current contact information and certifying that they had more than \$300 in COVID-19 related additional cost of attendance expenses. Any funds allocated under this class which are not distributed will be returned to the general pool.

Distribution Class 1.2 Students Who Have Not Graduated: The institution had 567 Title IV eligible domestic undergraduate students who were registered full time in face-to-face classes for

the spring 2020 semester and are registered for fall 2020 classes (Distribution Class 1.2). We allocated 85% of the funds not allocated to Distribution Class 1.1 for a total of \$584,179.50. We allocated \$500 to each student in this class as a base grant (1.2.a). We allocated an additional \$500 to each student in this class who resided on campus (1.2.b). We allocated the remaining funds for this distribution class based on each Distribution Class 1.2 student's spring 2020 PELL Grant award / the total spring 2020 awards for all PELL Grants for all Distribution Class 1.2 eligible students on his or her campus, for an additional award (1.2.c) ranging from \$0 to \$969.41. These three awards combine for a total award ranging from a low of \$500 to a high of \$1,969.41. To receive this payment, students must have completed a simple on-line form providing their current contact information and indicating the economic injuries they suffered as a result of COVID-19 related additional cost of attendance expenses. Any funds allocated under this class which are not distributed will be returned to the general pool.

We are developing a plan to rapidly and equitably, within the scope of all available guidance, distribute all funds, by need and upon application, remaining after Distribution Round 1.

Distribution Round 2

The institution had initially reserved \$103,090.25 for Round 2 (and possibly subsequent) distribution. On September 14, 2020 after numerous attempts had been made to contact students who might be eligible for Round 1 distributions and the deadline to apply for Round 1 distributions having expired 80 days earlier, \$125,505.14 initially allocated for Round 1 distributions but unclaimed was transferred to Round 2. This resulted in a total allocation of \$228,596.06 (all remaining unallocated Emergency Financial Aid Grant to Students funds) for Round 2 distribution.

Distribution Class 2.1 Students With Financial Hardships: The institution developed a rubric with 9 general classes of financial distress our students might have experienced due to COVID-19 (went home due to required isolation/quarantine, was temporarily required to quarantine or isolate on campus, self-supporting lost job, parent made major contributions and lost job or income, student had COVID-19 related medical treatment or hospitalization, parent contributed and lost job or income, student lost job, parent had hours cut, student had hours cut) and assigned a financial award ranging from \$125 to \$1,000 for each hardship. Title IV eligible domestic undergraduate students enrolled in face to face classes were sent an email asking them to briefly describe the financial hardships, if any, they had faced because of COVID-19. An employee then selected the student identified hardship qualifying for the largest award from the rubric and submitted this form for payment via check.

7. Any instructions, directions, or guidance provided by the institution to students concerning the Emergency Financial Aid Grants.

Recognizing that in addition to the other unbudgeted costs you may have incurred dealing with this virus is the cost of returning for graduation, we have allocated \$300 per domestic, Title IV eligible undergraduate graduate.

BUT, we are fiduciaries for this money. In order to send you a check we need you to verify your address and certify your need. Fortunately, this is a quick and easy process. Again, congratulations on the achievement, and we look forward to seeing you in person at graduation!

As you might have heard, we received a small amount of money from the federal government under the CARES Act for distribution to students who experienced economic distress as a result of the COVID-19 pandemic. Secretary DeVos stated the strong desire of the Department of Education that these funds be provided directly to students who had been financially impacted by COVID-19. We still have some of this money left to distribute.

If you are a degree seeking in person, Title IV eligible (i.e., filed a FASFA) undergraduate student, here's an opportunity to apply for some of these funds. ***Please understand – and this is so important it is in bold, red, italic, underlined type -- that these funds are first come first served, and when we're out, we're out.*** The next few lines show how to apply for this aid; please read and follow them carefully because running out of funds is a certainty and, as noted, it's first come, first served.

If you suffered a COVID-19 related or aggravated economic hardship, send an email from your @webber.edu account to <Redacted: Staff Email Address> stating:

- 1) Your name as you appear in our records;
- 2) Your current (i.e., the one you're likely to answer) phone; and
- 3) A brief but clear statement of the economic hardship you've encountered (remember, you may be asked for documentation) as a result of the global pandemic.

If you're granted an award, you will be notified via your official university email (your @webber.edu account) when your check is ready to pick up at the business office.

We hope you're doing well this semester and remind you that if you are experiencing challenges or difficulties, the sooner you let us know about them, the sooner we can help you in fixing them.

Distribution Class 3.0 The institution had 1,475 total undergraduate and graduate level students who were registered in classes for the fall 2021 semester. Webber allocated 100% of the third round of HEERF student portion in the amount of \$2,020,169 received on 05/20/2021. We allocated to each student in this class as a base grant determined by full time or part time status. We allocated an additional \$435.74 to each student in this class that was a Pell Grant eligible student. These four award levels resulted in a total award ranging from a low of \$349.40 to a high of \$1,732.87. To receive this payment, students must have been pre-registered for the fall 2021 semester at the time of data selection. Any funds allocated under this class which are not distributed will be returned to the general pool. Funds in the amount of \$10,795.55 were returned that were part of a larger draw down for HEERF checks and distributed to eligible students in person or mailed. On 3/14/22, there were 23 HEERF checks in the amount of \$10,795.55 had become stale-dated and they were voided as a result. These funds will be redistributed to other eligible students.
